## HELLO MEDICARE, IS THAT REALLY YOU?

Medicare will be conducting their Beneficiary Survey via phone due to the COVID-19 pandemic. If you are chosen for the survey you will receive a letter to schedule a phone interview and alert you that NORC, a company working with Medicare, will be calling you.

To make sure the call is legitimate, you can contact the Medicare surveyors (NORC) at 1-877-389-3429 to make sure it was them calling.

### **Traveling Tips**

To ensure a safe and enjoyable trip, it is important to plan ahead especially when it involves your health.

- On the top of the list is to visit your doctor to discuss your trip and any concerns.
- Bring along your <u>My Healthcare Tracker</u> with your list of medications. Call 800-333-4374 to order one today!
- Be aware that <u>Medicare generally does not</u> <u>cover the cost of care outside of the U.S.</u>, so check to see if your supplemental insurance may cover healthcare costs when you travel abroad.
- Keep emergency phone numbers handy in case of an emergency. These numbers can include your doctor, family members, and the police department.

### **Summer Safety Tips**

- Keep cool and avoid the outdoors on hot days.

- Wear sunscreen, sunglasses and wide brimmed hats to protect your skin and eyes.
