#### Medicare Card Scams & Data Breach Alert

In the past, Medicare beneficiaries used their Social Security number as their Medicare number.

In 2018, as a result of some changes instituted by the Center for Medicare & Medicaid Services (CMS) each Medicare beneficiary received a new card with a uniquely assigned combination of letters & numbers. This was done to help keep beneficiaries' identity and Social Security numbers secure.

Currently, fraudsters are still calling beneficiaries falsely claiming that Medicare is issuing new Medicare cards for different reasons. What is important to know is that **Medicare will not call beneficiaries to offer them new Medicare cards and request that they confirm their Medicare number.** 

Some examples of what scammers are offering are:

- Plastic Medicare Card
- Plastic Medicare Card with a chip in it
- Medicare Card with Covid-19 vaccination
- Medicare Card that is black and white

• Medicare Card with Primary Doctor's name on it <u>Please share this flyer</u> with others in your community and tell them to call our Helpline if they may be a victim of a Medicare card scam.

#### MEDICARE CARD DATA BREACH ALERT

Up to 254,000 Medicare beneficiaries' personal information may have been compromised in an online ransomware attack at a government subcontractor. (12/16/2022)

- Beneficiaries whose personal information may have been compromised should receive a letter from the Centers for Medicare & Medicaid Services about the data breach.
- Those impacted will be issued new Medicare cards and ID numbers in the coming weeks.

#### LONG ISLAND DOCTOR SENTENCED FOR MEDICARE BILLING SCHEME



Gastroenterologist Morris Barnard from Great Neck, NY was sentenced to 30 months in prison for health care fraud and ordered to pay over \$1.4 million in restitution to Medicare. Barnard

submitted over \$3 million in billings to Medicare for colonoscopy and gastroenterological procedures that were not performed. Most of these billings indicated that the services were rendered to disabled beneficiaries who were living in residential group homes.
